



# CONSTRUCTION & ROAD CLOSURE ALERT

## ROAD CLOSURE AT AVENUE 15 IN MADERA COUNTY

UPDATED: NOVEMBER 17, 2017

**FRESNO, CALIF.** – The California High-Speed Rail Authority (Authority), in cooperation with design-build contractor, Tutor-Perini/Zachry/Parsons (TPZP), announces Avenue 15 between Road 29 and Santa Fe Drive in Madera County will be closed as part of construction of an overcrossing. This overcrossing will eliminate the existing BNSF railroad crossing and allow vehicles to travel over both the high-speed rail alignment and BNSF railroad tracks. The closure is expected to start Monday, November 27, 2017.

This work is part of Construction Package 1 (CP 1), the first 32-mile stretch of high-speed rail between Avenue 19 in Madera County and East American Avenue in Fresno County.



**Avenue 15 will be closed to through traffic between Road 29 and Santa Fe Drive for approximately 18 months starting November 27, 2017.**



### WESTBOUND TRAFFIC

- Traffic going west on Avenue 15 will be detoured north onto Santa Fe Drive then west on Avenue 15 ½ then south on Road 29 and back onto Avenue 15.

### EASTBOUND TRAFFIC

- Traffic going east on Avenue 15 will be detoured north onto Road 29, then east on Avenue 15 ½ then south on Santa Fe Drive and back onto Avenue 15.

Traffic laws will be fully enforced and commuters are expected to be aware of the surrounding activities, remain alert and watch for construction vehicles and personnel. The public is asked to drive carefully and be extra cautious while traveling through the construction areas.
